



# COVID-19 STATEMENT

Dear Concerned Citizen,

Products and devices used to destroy, repel, trap or mitigate any pest including bacteria and viruses (including SARS-CoV-2 (the virus that causes COVID-19)) are classified by the United States Environmental Protection Agency (EPA) as Pesticides. The EPA further classifies pesticides into two categories. **Pesticide Devices** and **Pesticide Products**. Think of it this way, a mouse trap is a Pesticide Device but your household spray cleaner is a Pesticide Product. The WAAV Sprayer is classified as a **Pesticide Device**.

The best way for a company to make a claim that their Pesticide Product kills SARS-CoV-2 is by directly testing their Pesticide Product on SARS-CoV-2. Only a few highly specialized test labs are permitted to conduct these tests and even fewer have access to the actual SARS-CoV-2 virus. To address this shortage of available testing, a new task force of the American Society for Testing and Materials (ASTM International) has established a list of surrogate viruses. These surrogate viruses are easier for testing labs to obtain, can be safely handled at a larger number of test labs and most importantly are as hard or harder to kill as SARS-CoV-2. We are currently working on having the WAAV Sprayer tested directly on a surrogate of SARS-CoV-2 to prove its efficacy.

The EPA has an Emerging Virus Protocol list of Pesticide Products that the EPA “expects” will kill SARS-CoV-2 even though they have not been tested on the actual virus. This list is called List-N. List-N only includes surface Pesticide Products (disinfectants) registered by the EPA and will not include any type of Pesticide Devices like the WAAV Sprayer. Keep in mind that WAAV is an emerging technology and the EPA established its classifications and protocols long before anyone imagined that the power of ozone water could be in a device you could hold in your hand.

To protect yourself and your family, the Centers for Disease Control (CDC) recommends that you clean and disinfect frequently touched surfaces daily. The WAAV Sprayer generates ozone water on demand. Ozone water (aqueous ozone) is an established disinfectant tested to kill 99.99% of some of the hardest to kill viruses, including Influenza, Avian, Hepatitis and Canine parvovirus, faster than some of the Pesticide Products that are on List-N. WAAV is Safe, Non-toxic and leaves no chemical residue.

While we are confident that the WAAV Sprayer plays a vital role in the safety of our families and environment, we CANNOT AND DO NOT MAKE ANY CLAIM WHATSOEVER ABOUT WAAV'S ABILITY TO KILL SARS-CoV-2 (COVID-19).
